Bhutan as Lighthouse Presenting a Model Catalyst for a 21st Century Value-Centered World

The invitation is to become part of an unprecedented sovereign development consortium.

The offer is to utilize Bhutan as the first sovereign state to serve as a site for development of a truly sustainable 21st Century exemplar society, along with all associated energy, transportation, technology, agricultural, industrial and social infrastructures, facilities, and services.

Intro

The Queen Mother's vision for Bhutan's future development provides a unique opportunity, both nationally and globally, to become the model of a value -centered 21st century society, serving its people, the planet, and the larger community of living beings.

Through alignment of national values, Bhutan can assure preservation and protection of its natural resources, treasures and ecosystem, while evolving a contemporary, sustainable and thriving socio-economic enterprise.

National values align with and augment the Seven Pillars of Buddhist doctrine, via a national social contract, created and adopted by all the people of Bhutan.

The terms of this value-agreement provide a means to evaluate and judge past, present and future development initiatives and assure their alignment with National Values.

Through a values -mediated development process and facilitation platform, Bhutan can assure that no development project will carry with it negative or destructive consequences for its territory, fauna, flora, people, culture or society at large.

Through successful implementation of a national Bhutanese value-agreement, facilitation platform and infrastructure Bhutan will become a global beacon for societal transformation.



Benefits and Opportunities

As the global lighthouse for societal transformation, Bhutan has the potential to generate unprecedented benefits and rewards for its people and its treasury.

Political

The recent transition of Bhutan from monarchy to parliamentary democracy offers the opportunity to develop a values-centered hub in Asia, with global significance as a neutral mediation and negotiation center.

Positioning Bhutan as the "Switzerland of Asia" offers the opportunity to expand commerce and banking, as well as international presence and tourism.

Through branding of the Bhutanese National image, attraction of increased foreign direct investment and presence will be stimulated.

Branding will establish Bhutan as a global value Lighthouse for the world, with consonant degrees of domestic safety, order, and security.

Establishment of a globally recognized safe and secure sovereign territory will attract a highly skilled and affluent class of immigrants, in the information sector and retiree demographics, in turn driving expansion of services catering to those populations, including culture, arts and entertainment, health, wellness, and community institutions.

Economic

Based on a secure, neutral ,and socially ordered sovereign state located between two countries representing two of the top three economies in GDP (Purchasing Power Parity) in the world, China and India afford Bhutan a unique economic opportunity.

Via establishment of state of the art transactions, banking and technology, enabled blockchain currency facilities and infrastructure, Bhutan can assume a unique strategic position in global finance and commerce, as a new and innovative virtual transaction hub and wealth repository for Asia and the world with significant potential for disruption of global financial services and banking practices.

I.e., Brand enhancement of Bhutan via its economic transformation and service offerings will attract banks, financial service providers, investors, and tourism.



Social

Values-mediated development will incorporate third party contributions to a national well-being organization and fund, dedicated both to social causes and initiatives focused on health, education, equality, diversity, value distribution, and establishment of a comprehensive social safety net assuring provision of the essentials for survival, food, shelter and quality education for all.

In parallel to the above, a tax-on-value-flows derived from the economic transactional hub can fund establishment of centers and resources for grassroots entrepreneurial initiatives connecting Bhutanese entrepreneurs with a global marketplace.

Via ubiquitous communications networks and cellular services, a national communication protocol can be utilized to empower and enable every Bhutanese citizen to participate in defining the Bhutanese values statement, becoming a signatory to a "National Value Agreement", and serving as monitors and champions of its manifestation on a community level.

This would enable a real-time 'national value early warning system' for identifying and preventing potentially destructive or adverse development activities.

Technological

Bhutan affords a unique opportunity, in the context of technology and infrastructure development, based on its diversity of geological and meteorological characteristics and demographic distribution.

This initiative can catalyze design and development of new approaches for energy, technology, communications, information and infrastructure deployment.

At the core of this vision lies abandonment of large scale centralized industrial infrastructure development projects in favor of human-centered decentralized and distributed systems and networks.

Legal

By increasing the number of global stakeholders in the Bhutanese development agenda, greater visibility, energy, awareness and vested interest in Bhutan's continued independence, sovereignty, and security will be achieved.



Through avoidance of destructive project consequences, the need for risk-based diversion of financial resources can be significantly reduced liberating resources for mediation and alternative dispute resolution modalities.

Environmental

As stewards of Bhutan's natural resources and environment, a values-agreement and associated checklist for analysis of future development projects assures that no development gains are produced at the expense of existing ecosystems.

New technologies and practices can be designed to preserve and enable sustainable development 100% consonant with Buddhist and National principles and interests.

A secondary geopolitical asset warranting special focus is the water resources of Bhutan, which carry global potential significance, as a source of future foreign direct investment and potential post development income.

With a values focus, both domestic distribution challenges as well as foreign export opportunities can be pursued.

Call-to-Action

The strategy for achievement of this vision is a call-to-action by Her Majesty the Queen Mother, in the form of an invitation only meeting of the founders of the largest and most successful innovation and technology players in the private and philanthropic sectors.

The invitation is to become part of an unprecedented sovereign development consortium.

The offer is to utilize Bhutan as the first sovereign state to serve as a site for development of a truly sustainable 21st Century exemplar society, along with all associated energy, transportation, technology, agricultural, industrial and social infrastructures, facilities and services.

These leaders, and their associated enterprises and organizations will underwrite this initiative, at no cost to the Bhutanese treasury.

Upon successful completion of the minimally viable development initiatives in all areas of the total development vision, Bhutan will become the lighthouse for global transformation into a sustainable world.

This will position Bhutan and the members of the consortium to assume a leadership role and capitalize on subsequent global transformation initiatives.
